Summary: This project establishes a foundation for sustained inquiry and practice-based engagement regarding Catholic early childhood education. The project will draw upon a national cadre of experts to examine the landscape of early childhood education in the Catholic sector in order to map a research, outreach, and engagement agenda that Notre Dame's Alliance for Catholic Education can embrace.

Summary: A participatory, stakeholder informed case study of the implementation process and its short term impacts. Archival materials, a local survey of pastors, and

several semi-structured interviews with key project stakeholders contributed to the case study analysis.

Summary: The project establishes the foundation for a long-term research initiative focused on supporting Catholic school children's socioemotional wellness and mental health. A research trajectory is proposed to design appropriate survey tools, execute a pilot survey, conduct site visits, and synthesize both survey and case study data.

Summary: To reinvigorate the leadership mission among ACE Leadership cohorts, the goal of this project was to: (a) support professional administrative development rooted in the mission of Catholic education and current educational research; (b) bond Catholic school administrators more closely with the larger community of the Catholic Church, and the smaller communities of their own schools and of Catholic school leaders; and (c) foster the ongoing spiritual development of Catholic school administrators for the strengthening of their own vocation, especially the responsibility to the faith-life of their school communities.

Summary: The overarching purpose of this project was to conduct a process and outcome analysis of a novel, police- and community-driven strategy to address illicit drug dealing in street-level, open-air markets. The first goal of the project was to model and describe the elements, developmental stages, and operational steps of the street-drug intervention. The second goal of the project was to measure the impact of the strategy across three existing sites and an emerging site, using a matched control comparison site.

Summary: Weed and Seed, a community-based strategy sponsored by the U.S. Department of Justice (DOJ), was an innovative, comprehensive multiagency approach to law enforcement, crime prevention, and community revitalization. The Center: (a) reviewed archival data such as quarterly reports and performance measures; (b) conducted stakeholder interviews with Weed and Seed partners to assess challenges,

barriers, and successes; and (c) comprehensively addressed the connection between project activities and short- and long-term outcomes.

Summary: The purpose was to gauge the holistic impact of a comprehensive portfolio of local prevention/intervention efforts on gang dynamics within Guilford County. The major questions focused on: (a) is each individual program achieving its measurable outputs and outcomes? (b) what is the collective impact of this array of programs on gang violence prevention/intervention? (c) how well does this array of programs respond to identified community needs in actual practice? and (d) what gaps remain even after adding the current portfolio of programs?

Summary: The goal of this project was to augment research, evaluation, and technical assistance activities that were underway across the Middle District of North Carolina in support of Project Safe Neighborhoods. These activities included community-level needs assessments, evaluations of strategic interventions, gang crime incident reviews, analysis of crime data both pre- and post-intervention, and community safety surveys.

Summary: The goal of this project was to develop cross-site, summative data and distill a "how-to" approach for new and emerging disproportionate minority contact (DMC) sites. The Center conducted a rapid ethnographic assessment of four DMC sites featuring team-based data collection through group and individual interviews, observation, and document review. The major deliverable was a cross-site process and evaluation summary that featured public policy implications of DMC efforts.

Summary: To support the outreach, strategic planning, and accountability components of the Project Safe Neighborhoods Initiative across the Middle District of North Carolina, the Center for Youth, Family, and Community Partnerships: (a) maintained an informed awareness of local and national PSN programming; (b) provided PSN strategic planning
